

SUMMARY ANNUAL REPORT

For Guest Services, Inc. Group Medical and Dental Plan

This is a summary of the annual report of the Guest Services, Inc. Group Medical and Dental Plan, EIN 53-0164700, Plan No. 508, for the period January 01, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Guest Services, Inc. has committed itself to pay certain self-funded medical, dental and prescription drug claims incurred under the terms of the plan, which were administered on behalf of the plan by CareFirst BC/BS, Metropolitan Life Insurance Company and Express Scripts.

Insurance Information

The plan has contracts with EyeMed Vision Care and Kaiser Foundation Health Plan of The Mid-Atlantic to pay health, vision, prescription drug, and HMO claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2018 were \$1,785,028.
