Additionally, you may direct the investment of individual retirement accounts, choose from at least three diverse investment options, and change investment choices at least quarterly.

This means the Plan Fiduciary should not be liable for any investment losses that result from a participant's investment control, including a participant's election to use Target My Retirement[®].

Directing or transferring investment options — Certain investment options may have restrictions. See the Investment Option Summary for details. Compare the different TDF's to see how the mix of investments shift based on the TDF glide path.
